2012-13 Graduate Admission Criteria & Requirements

Thank you for your interest in Marymount University. Please apply online at www.marymount.edu/apply. The following items will be required:

• A \$40 nonrefundable application fee. (Applicants to the Doctor of Physical Therapy program will apply online at www.ptcas.org and pay a \$30 fee.) You may pay with a credit card, using our secure online payment system.

Official transcripts for all college/university work completed, sent directly to Marymount University's Office of Graduate Admissions, 2807 N. Glebe Road, Arlington, VA 22207, or via an online delivery system.

> For university coursework completed outside the U.S., an official course-by-course evaluation of your transcript is required from one of these approved evaluation agencies: World Education Services, Inc. (www.wes.org), World Educational Credentials Evaluators (http://users.erols.com/ wecewellington/), or AACRAO, the American Association of Collegiate Registrars and Admissions Officers, (www.aacrao.org).

Nondegree applicants simply indicate a program of interest on the online application and submit official transcript(s) showing a degree awarded.

Degree and certificate applicants should consult the grid that follows for additional criteria, including

• Application deadlines – Some programs operate on a rolling admissions policy, and some have specific deadlines. Applicants will be notified of the admission decision upon completion of a file review, once all application materials and credentials are received.

Recommendations – Some programs require one or more recommendations. Applicants will be given an opportunity to have their recommenders complete an online recommendation form, or download a form that can be completed by a recommender and sent directly to Marymount.

• Test scores – Some programs require a standardized test score, which can be sent directly to Marymount. This requirement is waived for applicants who hold a master's degree from an accredited college or university, with the exception of Counselor Education and Supervision (Ed.D.) and Physical Therapy (D.P.T.) applicants.

• Nonnative speakers of English must submit a satisfactory score from the Test of English as a Foreign Language (TOEFL), the International English Language Testing System (IELTS), or the Pearson Test of English Academic (PTE) or successfully complete ELS Educational Service's Level 112 in order to be considered for admission.
