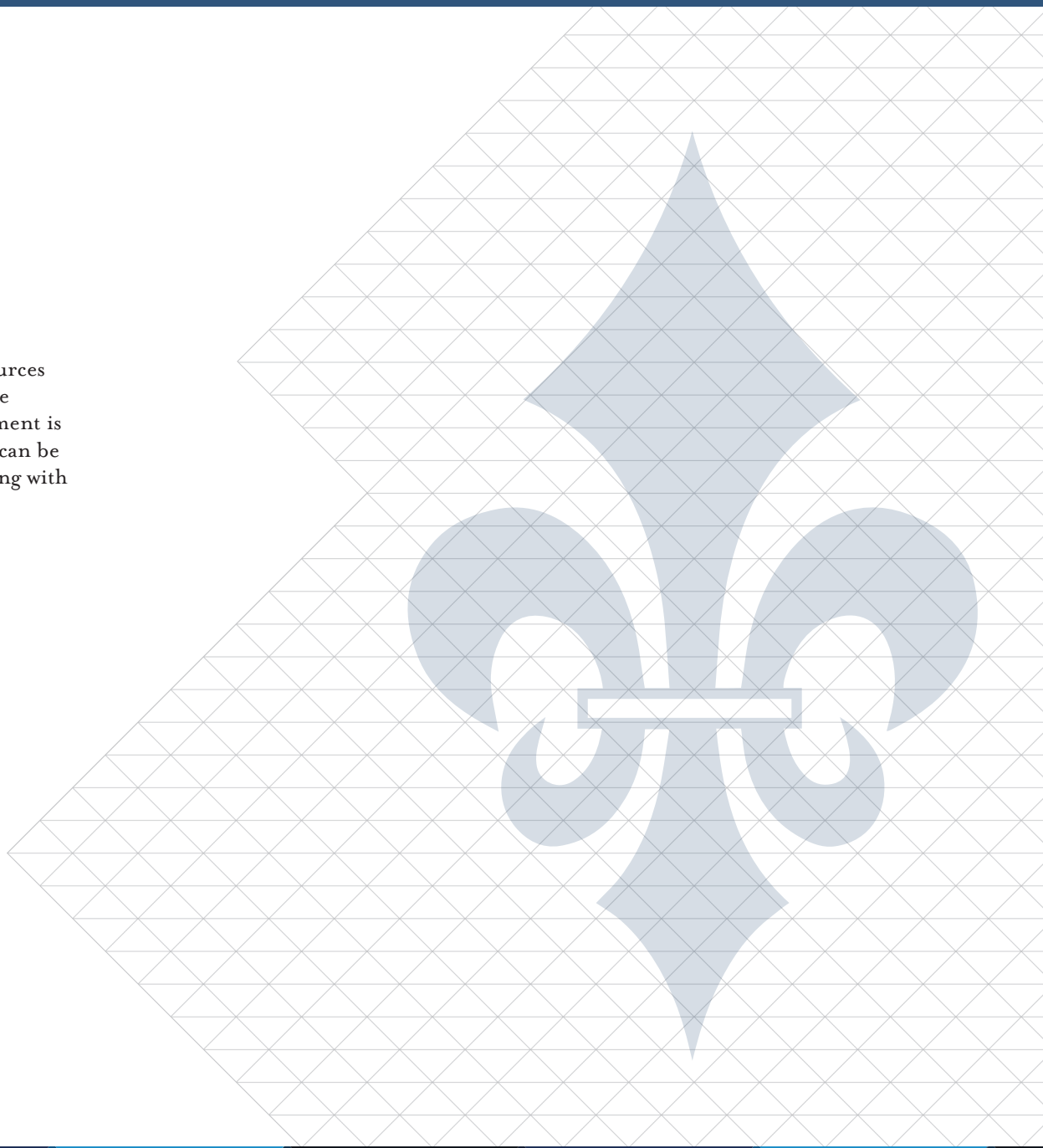
Dear Marymount Community,
